In years in which Christmas Eve and/or New Year’s Eve fall on Sunday, the retail distribution licensee shall be permitted to remain open on that Sunday, Christmas Eve or New Year’s Eve from 9:00 a.m. until 8:00 p.m.

**WHEREAS**, Joe Canal’s of Bellmawr and Liquor Mart are duly operating retail license establishment and are currently in compliance with all technical requirements, and have requested that Mayor and Borough Council permit hours on Sunday, December 24, 2023 and December 31, 2023 at 10:00 p.m. rather than the codified time of 8:00 p.m.; and

**WHEREAS**, the Borough desires to assist businesses upon reasonable requests in order to foster economic development and success within our business community whenever possible.

**A SHARED SERVICES AGREEMENT BY AND BETWEEN THE  
BOROUGH OF BROOKLAWN AND BOROUGH OF BELLMAWR FOR  
THE PROVISION OF EMERGENCY MEDICAL SERVICES**

**THIS DOCUMENT** constitutes an Shared Services Agreement pursuant to pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 *et seq.*, entered into by and between the Borough of Brooklawn, a body politic and corporate of the State of New Jersey with offices located at 301 Christiana Street, Brooklawn, New Jersey 08030, and the Borough of Bellmawr, a body politic and corporate of the State of New Jersey with offices located at 21 East Browning Road, Bellmawr, New Jersey 08031. The effective date of this Agreement is the 1<sup>st</sup> of January 2024.

**WITNESSETH:**

**WHEREAS**, the Borough of Brooklawn (hereinafter "Brooklawn") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, the Borough of Bellmawr (hereinafter "Bellmawr") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, Bellmawr has within its Department of Public Safety a full time, fully staffed Emergency Medical Services (EMS) operation, which provides certain emergency medical services to the residents of Bellmawr; and

**WHEREAS**, Bellmawr has agreed to supply EMS services to the residents of Brooklawn, of the nature supplied to its own residents, for the period of time commencing August 16, 2021 through January 1, 2024; and

**WHEREAS**, the proper and respective municipal officials were authorized to execute this Shared Services Agreement pursuant to Resolutions of their respective Governing Bodies, attached hereto and made a part of this Agreement; and

**WHEREAS**, Bellmawr has the expertise and capability to provide comprehensive Services to the Borough for the management of this Project;

**WHEREAS**, N.J.S.A. 40A:65-1, *et seq.* ("Uniform Shared Services and Consolidation Act") permits two local units to enter into a contract for any service which any party to the agreement is empowered to render within its jurisdiction; and

**WHEREAS**, Brooklawn and Bellmawr agree that their mutual public purposes and their best interest will be promoted by the execution and delivery of this Shared Services

Agreement pursuant to the powers conferred by the Uniform Shared Services and Consolidation Act; and

**WHEREAS**, by Resolution No. \_\_\_\_ adopted by the Brooklawn Borough's Mayor and Council, and Resolution # 12:220-23 adopted by the Bellmawr Borough's Mayor and Council, the Parties are authorized to enter into this Agreement;

**NOW, THEREFORE, IN CONSIDERATION** of the mutual covenants and promises herein contained, it is agreed by and between the parties as follows:

**1. TERM**

This Agreement shall be for a period of two (2) years, commencing January 1, 2024 through December 31, 2025 and shall be cancelable at the end of any calendar year upon sixty (60) days written notice by any party to this Agreement.

**2. FEE:**

Brooklawn shall pay a fee to Bellmawr in the amount of \$73,000 per year. The fee shall be paid in quarterly installments commencing upon the execution of this Agreement.

**3. AMBULANCE SERVICES**

Bellmawr has agreed to permit its Emergency Medical Services (EMS) to provide the same emergency medical services to the residents of the Brooklawn as it provides to the residents of Bellmawr. Additionally, Bellmawr shall be permitted to bill the residents of Brooklawn in the same manner and in the same amount as the residents of the Bellmawr are billed for such services. Bellmawr agrees to accept as full payment for its services rendered to the residents of Brooklawn under this Agreement the amount tendered in payment of said bill by a third-party medical insurance carrier or any such medical indemnity program offered by the United States of America and/or the State of New Jersey. Bellmawr agrees that all or any part of the bill submitted to a resident of Brooklawn under this Agreement not covered by a third-party medical insurance carrier or any such medical indemnity program offered by the United States of America and/or the State of New Jersey shall be waived.

**4. AUDIT**

Pursuant to the Single Audit Act of 1984, Bellmawr agrees to permit Brooklawn and/or its agents to examine any and all records relevant to this Agreement and shall make the same available upon demand at a reasonable time and place for the purpose of auditing the records, reports and documents relative to this Agreement.

**5. INDEMNIFICATION**

Brooklawn shall indemnify, hold harmless and defend Bellmawr, its elected officials, employees, officers and agents, from and against all liability, claims, suits, losses, damages,

costs and demands, on account of bodily injury, including death or property damage, arising out of or connected with the performance of the services under this Agreement. Bellmawr shall indemnify, hold harmless and defend Brooklawn, its elected officials, employees, officers and agents, from and against all liability, claims, suits, losses, damages, costs and demands, on account of bodily injury, including death or property damage, arising out of or connected with the performance of the services under this Agreement.

## **6. NOTICES**

All notices hereunder shall be in writing and sent certified mail, return receipt requested for the Borough of Bellmawr to the Borough Clerk, Borough of Bellmawr, 21 East Browning Road, Bellmawr, New Jersey 08031; and for the Borough of Brooklawn to the Borough Clerk, Borough of Brooklawn, 301 Christiana Street, Brooklawn, New Jersey 08030.

## **7. MISCELLANEOUS**

The following provisions shall apply to this Agreement:

### **A. Construction of this Agreement**

The parties acknowledge that this Agreement was prepared under New Jersey Law and shall therefore be interpreted under the laws of that State.

### **B. Amendments**

This Agreement may not be amended, altered or modified in any manner except in writing signed by the parties hereto.

### **C. Headings**

This section and any other headings contained in this Agreement are for reference only and shall not affect the meaning and interpretation of this contract.

### **D. Invalid Clause**

The invalidity of any clause contained herein shall not render any other provision invalid and the balance of this Agreement shall be binding upon all parties hereto.

### **E. Entire Agreement**

This Agreement shall consist of the entire Agreement of the parties and It IS acknowledged that there are no side or oral Agreements relating to this undertaking set forth herein.

### **F. Assignability**

3

This Agreement and all rights, duties and obligations contained herein may not be assigned without Bellmawr's prior written permission.

### **G. Affirmative Action**

The affirmative action provisions set forth in the documents attached hereto are incorporated herein and made a part hereof.

### **H. Funding**

In accordance with the provisions of N.J.S.A. 40A:11-15, this Agreement is subject to the availability and appropriation of sufficient funds in the year in which it is in effect.

## I. Waiver

It is understood and agreed by the parties that a failure or delay in the enforcement of any of the provisions of this Agreement by either of the parties shall not be construed as a waiver of those provisions.

**WHEREAS**, on or about November 19, 2023, the Borough of Bellmawr (“Borough”) lawfully authorized entering into a Contract with Utility Service Co., Inc. (“USG”) to provide professional services needed to maintain its 500,000 gallon water storage tank located at S. Bell Avenue and Leaf Avenue, Bellmawr, NJ 08031; and

**WHEREAS**, the parties previously negotiated a Water Tank Maintenance Contract that has previously been reviewed and approved by the Borough Solicitor as set forth in an opinion letter dated October 25, 2019, in a form attached to and made a part hereof (Exhibit “A”); and

**WHEREAS**, USG has submitted an Addendum in the form attached hereto and made a part hereof (Exhibit “B”) to the original Water Tank Maintenance Contract dated August 18, 2023; and

**WHEREAS**, said addendum is necessitated by a myriad of technical and legal issues, include significant delay time associated with the removal of multiple antennas from the Leaf and Bell Water Tower to permit the renovation thereof, the emergence of unanticipated PFNA issues associated with the Warren Avenue Water Tower resulting in further delays, as well as the re-design of the “Windrods” on the Leaf and Bell Water Tower needed to support the reinstallation of the numerous antennas presently under lease with the Borough; and

**WHEREAS**, the Water Department of the Borough of Bellmawr has reviewed and approved the cost associated with Contract Addendum and has recommended approval to the Mayor and Borough Council;

**WHEREAS**, the Borough Solicitor has review and approved as to form and substance, the Contract Addendum with USG.

**NOW, THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Bellmawr as follows:


