**AUTHORIZING THE EXPENDITURE OF FUNDS WITHOUT
COMPETITIVE BIDDING IN ACCORDANCE WITH N.J.S.A. 40A:11-6
FOR THE RESTORATION OF THE WARREN AVENUE WATER
TREATMENT PLANT**

WHEREAS, the Borough of Bellmawr (“Borough”) received a report of a failure of the potable water system at the Warren Avenue Water Treatment Plant, specifically, a critical failure of Well No. 3, and subsequent resultant failure of components related to the ion exchange resin treatment system ;and

WHEREAS, failure to take immediate and emergent action will result in a public health and safety hazard; and

WHEREAS, Stephen M. Bach, PE, RA, PP, CME, of Bach Associates, has issued correspondence dated February 9, 2024, outlining the nature of the emergency, the need for immediate action and has rendered an opinion that the public health safety and welfare of the residents and of the general public would be affected if not repaired immediately; and

WHEREAS, this emergency was not reasonably foreseeable by the Borough; and

WHEREAS, the authorization to complete the required repair work is limited to meet immediate needs; and


WHEREAS, Christopher F. Long, Esq has rendered an opinion dated February 9, 2024 that the Award of a Contract is permitted by law as an exception to the Local Public Contracts Law in accordance with N.J.S.A. 40A:11-6; and

WHEREAS, the Borough is satisfied that an emergency exists; and


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Bellmawr, County of Camden, and State of New Jersey as follows:

1. The provisions of the WHEREAS clauses set forth above are incorporated herein by reference and made a part hereof.
2. The expenditure of funds is authorized without competitive bidding in accordance with N.J.S.A. 40A:11-6 which permits emergency repair services for the restoration of the Warren Avenue Water Treatment Plant.
3. The Mayor and/or his designee is directed to take any and all actions necessary to effectuate the restoration authorized herein.







The date of this Agreement is the 14th day of February, 2024.

WITNESSETH

WHEREAS, the Borough of Woodlynne{hereinafter “Woodlynne”} is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

The Agreement and all of its terms, conditions and provisions are solely for the benefit of Woodlynne and Bellmawr and it is understood and agreed between parties hereto that the sole remedy of Woodlynne or Bellmawr in the event of any failure of this Agreement shall be the termination hereof.

All notices hereunder shall be in writing and sent certified mail, return receipt requested for the Borough of Bellmawr to the Borough Clerk, Borough of Bellmawr, at 21 East Browning Road, Bellmawr, New Jersey 08031 and for Woodlynne to the Borough Clerk, Woodlynne, at 200 Cooper Avenue, Woodlynne, New Jersey 08107

7. MISCELLANEOUS

The following provisions shall apply to this agreement:

- a. Construction of this agreement

The parties acknowledge that this agreement was prepared under New Jersey Law and shall therefore be interpreted under the laws of the State of New Jersey.

b. Amendments

This agreement may not be amended, altered or modified in any manner except in writing by the parties hereto.

c. Headings

This section and any other headings contained in this agreement are for references only and shall not affect the meaning and interpretation of this agreement.

d. Interpretations

Any questions regarding proper interpretation of the terms of this agreement shall be submitted by Municipal Administrator of the Provider, to the Municipal Attorney of the Provider and Recipient respectively, for interpretation. Absent a unanimous opinion, the matter shall be referred to a single arbitrator for binding arbitration. The cost of the arbitration shall be borne equally between the Provider and Recipient.

e. Remedy

It is understood that the sole remedy for breach of contract is termination under the termination clause. No monetary damages or back charges may be deemed or granted in any dispute over the administration of this contract except as may otherwise be provided for in this agreement.

f. Severability

Pursuant to N.J.A.C. 53:23-4.6 in the event this agreement is deemed void, unlawful, invalidated by a Court of competent jurisdiction or prove otherwise unenforceable, the other parts or sections shall be separable and remain in full force and effect.





SHARED SERVICE AGREEMENT BY AND BETWEEN THE BOROUGH OF WOODLYNNE AND THE BOROUGH OF BELLMAWR COUNTY OF CAMDEN, STATE OF NEW JERSEY RELATIVE TO INSPECTION, VIDEO TAPING AND CLEANING OF ITS SANITARY/STORM SEWER SYSTEM FOR THE BOROUGH OF WOODLYNNE.

THIS DOCUMENT constitutes an Uniform Shared Service Agreement pursuant to N.J.S.A. 40:8A-1 et seq. entered into by and between the BOROUGH OF WOODLYNNE, a body politic and corporate of the State of New Jersey with offices located at 200 Cooper Avenue, Woodlynne, New Jersey, 08107 (Woodlynne), and the BOROUGH OF BELLMAWR, a body politic and corporate of the State of New Jersey with offices located at 21 East Browning Road, Bellmawr, New Jersey, 08031(Bellmawr). The date of this agreement is the 14th day of February 2024.

WITNESSETH

WHEREAS, the Borough of Woodlynne (hereinafter "Woodlynne") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

WHEREAS, the Borough of Bellmawr (hereinafter "Bellmawr") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

WHEREAS, Woodlynne and Bellmawr wish to enter into an Agreement whereby Bellmawr would provide aid and assist Woodlynne in its televised inspection, video taping and cleaning of its sanitary/storm sewer collection system and

WHEREAS, by negotiations previously had between Bellmawr and Woodlynne, the terms and conditions of this agreement; and

WHEREAS, the proper and respective public officials are or will be authorized to execute this Shared Services Agreement pursuant to Resolutions of their respective governing bodies, attached hereto and made part of this agreement;

NOW, THEREFORE, AND IN CONSIDERATION of the mutual promises set forth herein, the parties hereto agree as follows:

1. SCOPE

1.1 Borough of Bellmawr shall assist Woodlynne in the appropriate manner in the inspection, videotaping and cleaning of the sanitary/storm sewer system within Woodlynne, commensurate with the needs of Woodlynne. It is distinctly understood and agreed that Bellmawr is to supply all necessary apparatus, equipment and equipment operator(s) for the inspection, video taping and cleaning of the Woodlynne sanitary/storm sewer system, in addition to manpower to be supplied by Woodlynne, consisting of such employees of the Public Works Department of the Borough of Woodlynne as so designated by Woodlynne.

1.2 Woodlynne agrees that it will be responsible to supply the necessary water for operation of the Jet Truck.

1.3 Should any rented equipment become damaged or lost in the mains or laterals due to incidents or accident, Woodlynne will reimburse Bellmawr for the cost of any repairs or cost of digging or other recovery operations.

2. TERMS

The services to be furnished hereunder shall commence on February 14, 2024 and ending at midnight on February 13, 2026. This agreement may be extended by mutual agreement, in writing, of both parties.

3. PAYMENT

3.1 The Borough of Woodlynne agrees to pay the Borough of Bellmawr the sum of One Hundred (\$100.00) Dollars per hour for the televising of sewer/storm mains and Seventy Five (\$75.00) Dollars per hour for the

televising of sewer laterals and Two Hundred (\$200.00) Dollars per hour for the cleaning of sewer/storm mains and disposal of debris. This sum shall include use of a Jet/Vac Truck, one (1) operator for the same and one (1) technician for the camera.

3.2 In the event Woodlynne requires additional manpower (laborers) from the Borough of Bellmawr, they will pay Bellmawr their current hourly rate plus twenty-two (22%) percent.

3.3. Woodlynne is to;

- a. Pay for all parts and labor on equipment, one-hundred (100%) percent,
- b. Pay for all material used i.e. (pipe, fittings concrete, etc), one-hundred (100%) percent,
- c. In the event Bellmawr needs to excavate a sewer main or lateral, Woodlynne will only be subjected to pay Fifty (50%) percent of equipment rate utilized on dig.

3.4 Invoices will be accompanied with detailed breakdown of bill, i.e. (hours, manpower, material, etc). Payment is due upon demand.

4. AUDIT

Pursuant to the Single Audit act of 1984, Bellmawr and Woodlynne agree to allow each other's agents to examine any and all records relevant to this agreement and shall make available upon demand at a reasonable time and place for the purpose of auditing the records, reports and documents relative to this agreement.

5. INDEMNIFICATION

Woodlynne and Bellmawr shall indemnify and hold each other harmless and defend each other, its elected officials, employees, officers and agents, from and against all liability, claims, suits, losses, damages, costs and demands, on account of bodily injury, including death or property damage, arising out of or connected with the services under this agreement.

The execution and delivery of this agreement shall not be construed to confer any right of action against either municipality on behalf of the other or on behalf of any other person, natural or otherwise, for any failure, neglect or breach of any term, covenant or condition thereof. The agreement and all of its terms, conditions and provisions are solely for the benefit of Bellmawr and Woodlynne, and it is understood and agreed between parties hereto that the sole remedy of either Woodlynne or Bellmawr in the event of any failure or breach of this agreement shall be the termination hereto.

6. AMENDMENTS

All amendments if any are to be agreed upon by both parties and shall be a separate agreement with all terms in writing and done by resolution by both governing bodies.






