RESOLUTION SUPPORTING THE APPLICATION OF CGT NEW JERSEY LLC TO OPERATE A CLASS 5 RETAIL FACILITY IN THE BOROUGH OF BELLMAWR CANNABIS ESTABLISHMENT OVERLAY ZONE

WHEREAS, pursuant to the “New Jersey Cannabis Regulatory Enforcement Assistance and Marketplace Modernization Act” (CREAMMA”), the Mayor and Council of the Borough of Bellmawr determined that in light of the foregoing it is in the best interest of the Borough to adopt and implement an ordinance permitting Class 5 Retail Cannabis Businesses in certain zones in the Borough (Ordinance No. 10:18-21, the “Ordinance”).

WHEREAS, on September 11, 2023 at a regular meeting of the Joint Land Use Board for the Borough of Bellmawr, CGT New Jersey LLC (“CGT”) received for property located at 143 Harding Ave. (Block 68, Lots 6, 6.02 and 6.03 (the “Property”) (1) conditional use and waiver, and (2) site plan approval to operate a Class 5 Retail Cannabis business on the Property; and

WHEREAS, CGT has provided sufficient information to demonstrate site control.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Bellmawr, County of Camden and State of New Jersey as follows:

1. The provisions of the Whereas Clauses set forth above are herein incorporated by reference and made a part hereof.
2. This Resolution applies to CGT and their proposed uses to be located at 143 Harding Ave. (Block 68, Lots 6, 6.02 and 6.03) in the Borough of Bellmawr’s Cannabis Establishment Overlay Zone in the Borough’s Light Industrial Zone.
3. The Borough of Bellmawr through the enactment of the Ordinance, has authorized cannabis Class 5 Retail business licenses to operate within its Cannabis Establishment Overlay Zone upon receiving the appropriate and other applicable local approvals.
4. The operation of Class 5 Retail facilities within the Borough requires the license holder comply with any applicable site requirements, local ordinance requirements, including but not limited, all state law and regulations, any terms and conditions of the Class 5 Retail licenses, and the issuance of a municipal business license in accordance with the Borough of Bellmawr.
5. The Mayor, Administrator, and/or Professionals or their designees for the Borough of Bellmawr are hereby authorized to communicate with the Cannabis Regulatory Commission (“CRC”) as necessary to confirm and/or supplement the contents of this Resolution as may be requested by the CRC.
6. The Borough of Bellmawr takes no other positions apart from the aforementioned regarding the issuance of a license to the applicant.



SELF-EXAMINATION OF BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Bellmawr has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2024 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Bellmawr that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.
