RESOLUTION AUTHORIZING THE APPROVAL AND AUTHORIZING TO EXECUTE AMENDMENT #1 TO THE REDEVELOPMENT AGREEMENT BY AND BETWEEN THE BELLMAWR BOROUGH, THE BELLMAWR REDEVELOPMENT AGENCY, BIG TIMBER JUNCTION, LLC., AND THE BELLMAWR WATERFRONT DEVELOPMENT, LLC

WHEREAS, the Borough, the Bellmawr RDA, the Redeveloper and BWD adopted and executed that certain Redevelopment Agreement among the parties on June 26, 2020 (the “Original Agreement” and together with the Amendment the “Redevelopment Agreement”); and

WHEREAS, the Redeveloper has proposed to the Borough and the Bellmawr RDA to implement the redevelopment of the Project Site, inclusive of the development of a Waterfront Park, a +/- One Million square foot Class A Logistics Center (the “Logistics Center”) and a new roadway identified by the NJDOT as the “Leaf Avenue Extension” as well as other on-site and off-site improvements as shown of that certain Site Plan prepared by SR3 Engineers, Sam Renauro, PE, entitled “Overall Site Plan” and dated July 14, 2023; and

WHEREAS, the redevelopment of the Project Site pursuant to the Site Plan would be in full conformance with the Redevelopment Plan, and would not require any variances; and

WHEREAS, Redeveloper is obliged to seek various approvals from Deptford Township and possibly other agencies including without limitation, the designation as redeveloper by Deptford Township and the adoption of a redevelopment plan and financial agreement in Deptford as well as associated resolutions, ordinances and approvals from the Deptford Planning Board and the Governing Body of Deptford Township; and

WHEREAS, the Bellmawr Joint Land Use Board on April 3, 2023, under Resolution number 2023-05, granted major subdivision approval of Block 79.01, Lot 9.01 into two (2) separate lots- Block 79.01, Lots 9.01 and 9.02, at the request of the New Jersey Department of Environmental Protection, so as a to facilitate the creation of the Waterfront Park lots as separate tax parcels in Bellmawr (i.e. Block 79.01, lot 9.02); and

WHEREAS, the Deptford Planning Board on May 3, 2023, Resolution number 2023-14 granted major subdivision approval of Block 1.02, Lot 1 into three (3) separate lots - Block 1.01, Lots 1, 1.01 and 1.02 at the request of NJDEP, so as to facilitate the creation of the Waterfront Park lots as separate tax parcels in Deptford (i.e. Block 1.02, Lots 1.01 and 1.02); and

WHEREAS, the Bellmawr Joint Land Use Board on November 13, 2023, under Resolution number 2023-13, granted Major Site Plan approval for the proposed development at the Project Site as depicted on the Site Plan (which approval shall control in the event of conflicts with associated Camden County approvals); and

WHEREAS, the Camden County Planning Board on January 23, 2024, as evidenced by confirmatory published meeting minutes granted County Site Plan

Approval for the proposed development at the Project Site as depicted on the Site Plan; and

WHEREAS, neither site plan approval reviewed or approved the details of the Leaf Avenue extension, since at the time of those approvals, the NJDOT proposed to undertake design and construction pursuant to the concept plan referred to below; and

WHEREAS, the NJDOT has communicated to Bellmawr and Camden County since prior to 2017 its intent to construct at NJDOT's expense a new roadway connecting Creek Road (a Camden County Road) and State Highway Route 42 ("Route 42") at the Creek Road exit / entrance ramp (referred to herein as the "Leaf Avenue Extension"); and

WHEREAS, the NJDOT has publicly stated to Bellmawr and Camden County that the purpose of building the Leaf Avenue Extension is to alleviate regional traffic delays on Creek Road and local Bellmawr roads caused by high volumes of state highway "thru" traffic directed by NJDOT onto Creek Road and adjacent Bellmawr municipal roads by NJDOT; and

WHEREAS, as of the date hereof the NJDOT has prepared a conceptual design for the Leaf Avenue Extension but has not in fact engineered or built the Leaf Avenue Extension, and traffic conditions on Creek Road and adjacent municipal roads remain congested and unacceptable; and

WHEREAS, the Borough, Camden County, and the Redeveloper all desire to cause the Leaf Avenue Extension to be constructed as soon as possible, so as to improve traffic flow on Creek Road and adjacent Bellmawr municipal roads and to also improve vehicle, bicycle and pedestrian access to the proposed Waterfront Park and Logistics Center; and

WHEREAS, in order to cause the Leaf Avenue Extension to be constructed in an expedited manner, the Redeveloper has agreed to construct the Leaf Avenue Extension pursuant to the terms of this Amendment and as more fully described in the Site Plan and in Exhibit D ("Leaf Avenue Extension Plans") attached hereto as will be described in full detail in the engineering plans to be provided by redeveloper and attached hereto upon receipt of all necessary governmental approvals; and

WHEREAS, the Parties intend that, once completed, the Leaf Avenue Extension shall become a Camden County Road; and

WHEREAS, Bellmawr intends to join Camden County in continuing efforts to pursue expense reimbursement from NJDOT for the cost to construct the Leaf Avenue Extension (inclusive of ROW acquisition costs, engineering, and construction costs); and

WHEREAS, in order to now facilitate the redevelopment of the entire Project Site consistent with the Site Plan (inclusive of the Waterfront Park, the Logistics Center and the Leaf Avenue Extension), the Parties desire to amend the Redevelopment Agreement as described herein.


NOW, THEREFORE BE IT RESOLVED, by the Council of the Borough of Bellmawr, in the County of Camden and State of New Jersey, as follows:

- 1. The **WHEREAS** clauses set forth above shall be incorporated herein as if set forth in full and made part of this Resolution.
- 2. The Mayor and Council of Bellmawr Borough hereby approves Amendment #1 in the form attached hereto and made a part hereof and further authorizes the Mayor, President of Council, Borough Clerk and Borough Solicitor or their respect designees, to execute Amendment #1 aforesaid, and take any and all necessary actions to effectuate the purposes thereof.
