WHEREAS, this Agreement is established in accordance with the provisions of the Uniform Shared Services and Consolidation Act, P.L.2007, c.63 (C.40A:65-1, et seq.), approved on April 3, 2007 as a means for municipalities and school districts to engage in more efficient operations and services in a cost-effective manner; and

WHEREAS, N.J.S.A. 40A:65-1, et seq., ("Uniform Shared Services and Consolidation Act") permits two or more local units to enter into a contract for any service which any party to the Agreement is empowered to render within its jurisdiction; and

WHEREAS, Bellmawr and Haddon Heights agree that their mutual public purposes and their best interests will be promoted by the execution and delivery of a Shared Services Agreement pursuant to the powers conferred by the Uniform Shared Services and Consolidation Act; and

NOW, THEREFORE BE IT RESOLVED, that Borough Council of the Borough of Bellmawr as follows:

1. The provisions of the WHEREAS clauses set forth above are incorporated herein by reference and made a part hereof.

WHEREAS, Bellmawr and Woodlynne agree that their mutual public purposes and their best interests will be promoted by the execution and delivery of a Shared Services Agreement pursuant to the powers conferred by the Uniform Shared Services and Consolidation Act; and

**RECOGNIZING THE INTERNATIONAL HOLOCAUST REMEMERANCE
ALLIANCE DEFINITION OF ANTISEMITISM**

WHEREAS, in the spirit of the Stockholm Declaration that states: “with humanity still scarred by antisemitism and xenophobia, the international community shares a solemn responsibility to fight those evils”, the committee on Antisemitism and Holocaust Denial called the IHRA Plenary in Budapest, 2015, to adopt the below working definition of the antisemitism; and

WHEREAS, on May 26, 2016, the Plenary Bucharest decided to adopt the following non-legally binding working definition of antisemitism:

“ANTISEMITISM is certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities.”

WHEREAS, manifestations might include the targeting of the state **of** Israel, conceived as a Jewish collectivity. However, criticism of Israel, similar to that leveled against any other country, cannot be regarded as anti-Semitic. Antisemitism frequently charges Jews with conspiring to harm humanity, and it is often used to blame Jews for “why things go wrong.” It is expressed in speech, writing, visual forms and action, and employee sinister stereotypes and negative character traits.

Contemporary examples of antisemitism in public life, the media, schools, the workplace, and in the religious sphere could, taking into account the overall context, include, but are not limited to:

Calling for, aiding, or justifying the killing or harming of Jews in the name of a radical ideology or an extremist view of religion.

Making mendacious, dehumanizing, demonizing, or stereotypical allegations about Jews as such or the power of Jews as collective-such as, especially but not exclusively, the myth about a world Jewish conspiracy or of Jews controlling the media, economy, government or other societal institutions.

Accusing Jews as a people of being responsible for real or imagined wrongdoing committed by non-Jews.

Denying the fact, scope, mechanisms (e.g., gas chambers) or intentionality of the genocide of the Jewish people at the hands of National Socialist Germany and its supporters and accomplices during World War II (the Holocaust).

Accusing the Jews as people, or Israel as a state, or to alleged priorities of Jews worldwide, than to the interests of their own nations.

Denying the Jewish people their right to self-determination, e.g., by claiming that the existence of a State Israel is a racist endeavor.

Applying double standards by requiring of it a behavior not expected or demanded of any other democratic nation.

Using the symbols and images with classic antisemitism (e.g. claims of Jews killing Jesus or blood libel) to characterize Israel or Israelis.

Drawing comparisons of contemporary Israel policy of that of the Nazis.

Holding Jews collectively responsible for actions of the State of Israel.

WHEREAS, antisemitic acts are criminal when they are so defined by law (for example, denial of the Holocaust or distribution of antisemitic materials in some countries).

WHEREAS, criminal acts are anti-Semitic when the targets of attacks, whether they are people or property-such as buildings, schools, places of worship and cemeteries-are selected because they are, perceived to be, Jewish or linked to Jews.

WHEREAS, discrimination is the denial to Jews of opportunities or services available to others and is illegal in many countries.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Bellmawr does hereby recognize the International Holocaust Remembrance Alliance Definition of Antisemitism.
