**FIXING THE RATE OF INTEREST TO BE CHARGED ON
DELINQUENT TAXES, SEWER, WATER, ASSESSMENTS**


WHEREAS, N.J.S.A. 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for non-payment or the late payment of taxes as provided by law,

BE IT RESOLVED by the Mayor and Council of the Borough of Bellmawr, County of Camden, State of New Jersey as follows:


1. The Tax Collector is hereby authorized and directed to charge eight (8) per cent per annum of the first \$1,500.00 on all delinquent taxes, water and sewer bills, as well as local improvement assessments for the year 2022, except the eighteen (18) percent per annum on any amount in excess of \$1,500.00 against any particular property.
2. The Borough of Bellmawr shall allow a grace period of ten (10) days before the imposition of said interest charges on delinquent taxes in accordance with N.J.S.A. 54:4-67.
3. The Borough of Bellmawr shall allow a grace period of thirty (30) days before the imposition of said interest charges on delinquent water bills. If taxes, water and sewer bills are not paid within their respective grace periods than interest charges will be computed from the date taxes and water utility charges are due.

PLAN TO IMPLEMENT CASH MANAGEMENT FOR THE BOROUGH OF BELLMAWR FOR THE YEAR 2025

This plan is established to comply with the requirements of N.J.S.A. 40A:5-14 and to provide a guide to municipal officials and employees in carrying out their duties concerning the receipts and disbursement of all funds of the Borough of Bellmawr, Camden County.

The following requirements shall be adhered to:

- A. The Borough of Bellmawr shall annually, at its reorganization meeting designate the legal depositories for all municipal funds. The resolution may be amended or supplemented from time to time as the Borough of Bellmawr deems necessary. Such resolution (s) shall be deemed a part of the Cash Management Plan.
- B. Legal Depositories for New Jersey municipal units are required by N.J.S.A.40A:5-14 to deposit public funds in a bank or trust company having its place of business in the State of New Jersey and organized under the laws of the United States or of the State of New Jersey or the New Jersey Cash Management Fund. N.J.S.A. 40A:5-15.1 provides a list of securities which may be purchased by New Jersey municipal units. The Borough of Bellmawr shall only deposit public funds in public depositories protected from loss under the provisions of the Governmental Unit Deposit Protection Act. ("GUDPA) was enacted in 2070 to protect Governmental Units from a loss of funds on deposit with a failed banking institution in New Jersey. The law requires governmental Units to deposit public funds only in public depositories located in New Jersey, where the funds are secured in accordance with the act.

Public funds are defined as the funds of any Governmental Unit. Public depositories include Saving and Loan institutions, bank (both State and National banks) and savings bank the deposits of which are federally insured. All public depositories must put up collateral to secure the deposits of Governmental Units in any public depository. If collateral of all other public depositories, is available to pay the full amount of their deposits to the Governmental Units.

- C. The Borough of Bellmawr shall annually establish by resolution adopted at it annual reorganization meeting the required signatories to all municipal bank accounts.
- D. All municipal funds received by any official or employee shall be either deposited within 48 hours to an interest-bearing account in the name of Borough of Bellmawr, or shall be turned over to the Collector within 48 hours of receipt.
- E. All revenues received by the Collector shall be deposited to interest bearing accounts in the legal depositories.
- F. The following funds shall not be required to be maintained in interest bearing account:
 - 1. Change Funds
 - 2. Petty Cash Funds
 - 3. Payroll Funds
 - 4. Trust funds to the extent that the deposit of such funds to an interest-bearing account would require by law the payment of interest to the provider of funds.
 - 5. Checking accounts established for the express purpose of paying bills approved by the governing body. The balances in these funds shall be kept at the minimum amount required for the orderly operation of the account.

- 6. Compensating balances maintained for the purpose of obtaining specific services from financial institutions. Such accounts shall be established only under terms of written agreements approved by the Mayor and Council of the Borough of Bellmawr.
- G. The Tax Collector (and Utilities Collector) shall deposit all funds to an interest-bearing account of the Treasurer.
- H. No municipal funds shall be disbursed by the Treasurer prior to approval of the Mayor and Council except for:
 - 1. Debt Service Payments
 - 2. Investments
 - 3. Payroll turnovers to agencies
 - 4. Discount vouchers


Debt service payments and discount vouchers must be ratified after payment.

It shall be the responsible of the Treasurer to analyze the cash flow and to invest funds in legal investments so as to maximize interest earnings. When investing funds in commercial banks, savings banks, savings and loan etc. The Treasurer shall obtain a minimum of three quotations and shall invest at the institution offering the highest effective rate. The Treasurer shall determine which type of legal investment will best serve the needs of the municipality and is authorized to place the funds in any such legal investments, unless otherwise restricted by the governing body.

The Treasurer shall report monthly all investment transactions as required to N.J.S.A. 40A:5-15, to the Mayor and Council of the Borough of Bellmawr.




