WHEREAS, Joseph Ciano, Director of Public Works has recommended to the Governing Body that it would be in the best interest of the Borough to apply said grant funds;



## RESOLUTION #03:68-22

### **SHARED SERVICE AGREEMENT BY AND BETWEEN THE BOROUGH OF AUDUBON AND THE BOROUGH OF BELLMAWR, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AND RELATIVE TO THE RENTAL OF EQUIPMENT AND MANPOWER FOR ASPHALT REHABILITATION AND CONCRETE REHABILITATION OF VARIOUS ROADWAYS AND PUBLIC GROUNDS WITHIN AUDUBON.**

**THIS DOCUMENT** constitutes a Uniform Shared Service Agreement pursuant to N.J.S.A. 40:65-1 et seq. entered into by and between the Borough of Audubon, a body politic and corporate of the State of New Jersey with offices located at 606 West Nicholson Road, Audubon, New Jersey, 08106 {Audubon}, and the Borough of Bellmawr, a body politic and corporate of the State of New Jersey with offices located at 21 East Browning Road, Bellmawr, New Jersey, 08031 {Bellmawr}. The date of this Agreement is the 15th day of March, 2022

#### **WITNESSETH**

**WHEREAS**, the Borough of Audubon (hereinafter "Audubon") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, the Borough of Bellmawr {hereinafter "Bellmawr"} is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, Audubon and Bellmawr wish to enter into an Agreement whereby Bellmawr would provide Manpower and Equipment for the purpose of asphalt/concrete/sewer rehabilitation of various roadways and public grounds within Audubon.

**WHEREAS**, by negotiations previously had between Bellmawr and Audubon, the terms and provisions hereafter set forth were determined and agreed thereto; and

**WHEREAS**, Audubon and Bellmawr intend by virtue of this document to set forth the terms and conditions of this agreement; and

**WHEREAS**, the proper and respective public officials are or will be authorized to execute this Shared Services Agreement pursuant to Resolutions of their respective governing bodies, attached hereto and made part of this agreement;

**NOW, THEREFORE, AND IN CONSIDERATION** of the mutual promises set forth herein, the parties hereto agree as follows:

#### **1. SCOPE**

- 1.1 The Borough of Bellmawr will provide Manpower and Equipment for the purpose of the asphalt/concrete of various roadways and public grounds within Audubon.
- 1.2 Audubon will pay all cost of asphalt under contract with American Asphalt Company, Inc. and pay all cost associated with local vendors for concrete, topsoil and DGA, dense graded aggregate (lowest quoted)
- 1.3 The Borough of Bellmawr will be responsible for all mark-outs to be obtained from New Jersey One Call.
- 1.4 The Borough of Audubon is responsible to provide as-built plans of various roadways in need of repair if available.
- 1.5 The Borough of Bellmawr is responsible for removal of failed sub-base materials.
- 1.6 The Borough of Bellmawr is responsible for the installation of 3 inch paving of roadways utilizing HMA 19M64 (base mix). If agreed upon lesser or greater depths to be installed.
- 1.7 The Borough of Bellmawr is responsible for the installation of 2 inch paving of roadways utilizing HMA 9.5M64 (top mix). If agreed upon lesser or greater depths to be installed.
- 1.8 The Borough of Audubon is responsible for storage/usage of excavated milling materials. All materials to be stored at Audubon Public Works Department.
- 1.9 The Borough of Audubon will be responsible for traffic control if needed and for notification of residents and businesses.
- 1.10 The Borough of Audubon will be responsible for any tree pruning, fence removal prior to work commencing.
- 1.11 The Borough of Bellmawr will be responsible for concrete removal and disposal.



## **2. TERM**

The services to be furnished hereunder shall commence between March 24, 2022 and ending by March 23, 2023. This agreement may be extended by the mutual agreement, in writing, of the parties.

## **3. PAYMENT**

The Borough of Audubon agrees to pay Bellmawr \$60.00 per man-hour, per man, plus \$45.00 per hour for asphalt equipment rental. The Borough of Audubon agrees to pay Bellmawr \$60.00 per man-hour for concrete rehabilitation plus \$45.00 per hour for equipment rental. A 5% Administration fee will be charged based on total cost labor & equipment supplied by Bellmawr.

## **4. AUDIT**

Pursuant to the single audit Act of 1984, Bellmawr and Audubon agree to allow each other's agents to examine any and all records relevant to this agreement and shall make available upon demand at a reasonable time and place for the purpose of auditing the records, reports and documents relative to this agreement.

## **5. INDEMNIFICATION**

Audubon and Bellmawr shall indemnify and hold each other harmless and defend each other, its elected officials, employees, officers and agents, from and against all liability, claims, suits, losses, damages, costs and demands, on account of bodily injury, including death or property damage, arising out of or connected with the performance of the services under this agreement.

The execution and delivery of this agreement shall not be construed to confer any right of action against either municipality on behalf of the other or on behalf of any other person, natural or otherwise, for any failure, neglect or breach of any term, covenant or condition thereof. The agreement and all of its terms, conditions and provisions are solely for the benefit of Bellmawr and Audubon, and it is understood and agreed between parties hereto that the sole remedy of either Audubon or Bellmawr in the event of any failure or breach of this agreement shall be the termination hereof.

## **6. NOTICES**

All notices hereunder shall be in writing and sent certified mail, return receipt requested for the Borough of Bellmawr to the Borough Clerk, Borough of Bellmawr, at P.O. Box 368 Bellmawr New Jersey, 08031 and for the Borough of Audubon to the Borough Clerk, Borough of Audubon,

7. MISCELLANEOUS

The following provisions shall apply to this agreement:

a. Construction of this Agreement

The parties acknowledge that this agreement was prepared under New Jersey Law and shall therefore be interpreted under the laws of the State.

b. Amendments

This agreement may not be amended, altered or modified in any manner except in writing signed by the parties hereto.

c. Headings

This section and any other headings contained in this agreement are for references only and shall not affect the meaning and interpretation of this agreement.







**RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BY AND BETWEEN  
THE BOROUGH OF BELLMAWR AND THE CITY OF GLOUCESTER CITY FOR THE  
PROVISION OF FUEL IN ACCORDANCE WITH N.J.S.A. 40A:65-1 ET SEQ.**

**WHEREAS**, the Borough of Bellmawr (Borough”) and the City of Gloucester City (“City”) desire to enter into a Shared Services Agreement (“Agreement”) pursuant to the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et seq.) (“Shared Services Act”), whereby the Borough shares access to its fuel with the City; and

**WHEREAS**, the Borough is a body politic organized under the laws of the State of New Jersey and located in the County of Camden; and

**WHEREAS** the City is a body politic organized under the laws of the State of New Jersey and located in the County of Camden; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the “Act”), authorized local units of this State to enter into an Agreement with any other local unit or units to provide or receive any service that each local unit participating in the Agreement is empowered to provide or receive in its own jurisdiction; and

**WHEREAS**, the City is in need of a fuel source due to an emergent breakdown of its pumping equipment; and

**WHEREAS**, the Borough is willing to assist the City by permitting usage of its fuel facilities; and




1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.

**SHARED SERVICES AGREEMENT**  
**BY AND BETWEEN THE BOROUGH OF BELLMAWR AND THE CITY OF**  
**GLOUCESTER CITY, FOR FUEL PURCHASES**

This Agreement, dated this 24<sup>TH</sup> day of March, 2022, between the Borough of Bellmawr, 21 East Browning Road, Bellmawr, NJ 08031 ("Bellmawr") and the City of Gloucester City, 512 Monmouth St., Gloucester City, NJ 08030 ("Gloucester City"). The effective date of this Agreement is the first day of March, 2022.

**WHEREAS**, the Borough of Bellmawr (hereinafter Bellmawr) is a body politic organized under the laws of the State of New Jersey and located in the County Camden; and

**WHEREAS** the City of Gloucester City (hereinafter Gloucester City) is a body politic organized under the laws of State of New Jersey and located in the County, of Camden; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the "Act"), authorized local units of this State to enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

**WHEREAS**, Gloucester City is in need of a fuel source due to an emergent breakdown of its pumping equipment; and

**WHEREAS**, Borough of Bellmawr is willing to assist Gloucester City by permitting usage of its fuel facilities; and

**WHEREAS**, in the spirit of inter-municipal cooperation, and in furtherance of the principles underlying the Act, Bellmawr and Gloucester City (collectively, the "Parties"), have negotiated an Agreement for the shared provision of the services within their respective jurisdictions; and

**WHEREAS**, the terms and conditions of this undertaking are set forth below; and

**WHEREAS**, the Parties have each duly authorized their proper officials to enter into and execute this Agreement; and

**NOW THEREFORE, AND IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH HEREIN, BELLMAWR AND GLOUCESTER CITY AGREE AS FOLLOWS:**

1. **PURPOSE.** In an effort to more economically and efficiently provide governmental services, the governing bodies of Bellmawr and Gloucester City have entered into negotiations wherein Gloucester City would utilize on a temporary basis, Bellmawr's fueling facility until the Gloucester City facility is brought back online and fully operational. The legal authority for such Interlocal Services is found in N.J.S.A 40:8A-1 et seq. and N.J.A.C. 5:23-4.6 et seq. The governing bodies of Bellmawr and Gloucester City have determined that it is in the mutual best interest of each municipality for Gloucester City to provide the services to Bellmawr, and in return, Bellmawr will compensate Gloucester City as set forth herein. Gloucester City will provide the services as set forth within this agreement for so long as Gloucester City has a need therefore.

2. **TERM.** This Agreement shall commence on March \_\_, 2022 through December 31, 2022. However, either party has the right to terminate this Agreement for any reason on ninety (90) days written notice to the other party following the adoption of a Resolution by the governing body of the entity terminating this Agreement authorizing the termination. In the event that either party defaults in the performance of any of its obligations under this Agreement after receiving written notice of same and failing to cure such default within thirty days of said written notice, the non-defaulting party shall be entitled to terminate this Agreement.

3. **SERVICES.** Bellmawr shall permit Gloucester City access to its fueling facilities.

4. **PAYMENT.** In consideration for the services rendered by Bellmawr, Gloucester City shall reimburse Bellmawr its direct cost to supplying fuel to Gloucester City plus a six (6%) percent administrative fee.



5. INDEMNIFICATION. Bellmawr and Gloucester shall mutually indemnify and hold harmless the other, its officers, employees and agents, harmless from and against any and all claims of whatever nature or type arising from the provision of the services identified herein, so long as the actions upon which the demand or claim, or assertion of liability are founded, were performed in the course of carrying out official duties on behalf of either parties hereto and were not out of the scope of services or performed in bad faith; and did not constitute actual fraud, actual malice, willful misconduct, intentional wrong doing or a criminal act. Such indemnification shall include payment of reasonable attorney's fees and costs in the defense of any claim made by a third person. This indemnification is not limited to any insurance coverage afforded to Gloucester City or Bellmawr.

6. ENTIRE AGREEMENT. This Agreement represents the entire agreement between the Parties and cannot be changed or modified orally. This Agreement may be supplemented, amended or revised only by a writing that is signed by all of the parties hereto.


7. SEVERABILITY. If any part of this Agreement shall be held to be unenforceable, the rest of this Agreement shall nevertheless remain in full force and effect.


8. WAIVER. Failure to insist upon strict compliance with any of the terms, covenants, or conditions of this Agreement at any one time shall not be deemed a waiver of such term, covenant, or condition at any other time nor shall any waiver or relinquishment of any right or power herein at any time be deemed a waiver or relinquishment of the same or any other right or power at any other time.
