**WHEREAS**, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults twenty-one (21) years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

**WHEREAS**, on or about December 30, 2021, the Borough of Bellmawr ("Borough") adopted Ordinance #10:18-21, entitled, "An Ordinance Of The Borough Of Bellmawr, County Of Camden And State Of New Jersey Amending Chapter 260 Land Use And Development To Provide For A Cannabis Establishment As Conditionally Permitted Use Overlay Zone"; and

**WHEREAS**, zoning permits for Recreational Cannabis applicants shall be required in all cases and be required to pay appropriate and necessary fees as set forth below, as well as escrows review fees for certain Borough professional services for the processing of same; and


**WHEREAS**, predicated upon these factors, it is the opinion of Borough Council, as well as the Borough Solicitor, that the proposed use of a "licensed medical and adult use cannabis dispensary" is a permitted use at the current location of the Cureleaf facility under Ordinance #10-18-21.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Bellmawr, in the County of Camden and State of New Jersey as follows:


1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
2. The Borough Council of the Borough of Bellmawr authorizes and establishes a Zoning Permit Application Fee for any Recreational Cannabis applicant in the amount of two-thousand five-hundred dollars (\$2,500.00) for an application fee as well as an additional two-thousand five-hundred dollars (\$2,500.00) posted for associated escrow fees to any legal and /or professional engineering/planning review fees for the subject application.
3. This Resolution shall take effect immediately.
