**RESOLUTION RESCINDING RESOLUTION #06:122-23 AWARDING THE  
CONTRACT FOR SECURITY CAMERA UPGRADES AT VARIOUS  
MUNICIPAL OWNED SITES TO OZITUS INTERNATIONAL, INC. AND  
AWARDING THE CONTRACT FOR SECURITY CAMERA UPGRADES AT  
VARIOUS MUNICIPAL OWNED SITES TO INDEPENDENT ALARM  
INCORPORATED**

**WHEREAS**, specifications were completed and bids were properly advertised by the Borough of Bellmawr (“Borough”) for the Security Camera Upgrades at Various Municipal Owned Sites project; and

**WHEREAS**, the Borough received two (2) bids for this Contract on April 14, 2022, as follows:

1. Ozitus International, Inc.	\$110,859.40
2. Independent Alarm Incorporated	\$131,270.00

**WHEREAS**, at its June 23, 2022, regular meeting, the Borough awarded the contract for Security Camera Upgrades at Various Municipal Owned Sites to Ozitus International, Inc. (“Ozitus”) via resolution #06:122-23; and

**WHEREAS**, following the award, via correspondence dated July 13, 2022, Vijay K. Verma, President & CEO of Ozitus, advised that Ozitus will no longer be providing information technology, consulting and deployment of technological solutions to the law enforcement, public safety and security industries and as such, Ozitus formally requested the withdraw of their bid; and

**WHEREAS**, following discussion with the Borough, via opinion letter dated July 22, 2022, the Borough Solicitor rendered a legal opinion recommending that the Borough permit the withdrawal of the bid submitted by Ozitus and rescind resolution #06:122-23 awarding the contract to Ozitus; and

**WHEREAS**, the Borough desires to rescind the resolution awarding the contract for Security Camera Upgrades at Various Municipal Owned Sites to Ozitus and to permit Ozitus to withdraw its bid submitted for Security Camera Upgrades at Various Municipal Owned Sites; and

**WHEREAS**, following the withdrawal of the bid submitted by Ozitus, the apparent low bid for the contract was submitted by Independent Alarm Incorporated (“Independent Alarm”); and

**WHEREAS**, via opinion dated July 22, 2022, the Borough Solicitor rendered a legal opinion that the bid submitted by Independent Alarm contained no defects and recommended the award of the contract to Independent Alarm; and

**WHEREAS**, the Borough concurs with said recommendations of the Borough Solicitor; and

**WHEREAS**, the Borough has therefore determined that Independent Alarm is the lowest qualified bidder for the Security Camera Upgrades at Various Municipal Owned Sites project, having submitted a bid in accordance with the Bid Specifications and Advertisement; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bellmawr, County of Camden, State of New Jersey as follows:

1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
2. The award of the contract for the Security Camera Upgrades at Various Municipal Owned Sites project via resolution #06:122-22 to Ozitus International, Inc. is hereby rescinded.
3. The Borough hereby accepts the withdrawal of the bid submitted by Ozitus International, Inc. for the Security Camera Upgrades at Various Municipal Owned Sites project.
4. The Contract for the Security Camera Upgrades at Various Municipal Owned Sites project is awarded to Independent Alarm Incorporated.
5. Funds are available for payment of this Contract.
