WHEREAS, Joseph Ciano, Director of Public Works has recommended to the Governing Body that it would be in the best interest of the Borough to apply said grant funds;







NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Bellmawr as follows:


