RESOLUTION AUTHORIZING SETTLEMENT OF A REVERSE TAX APPEAL

WHEREAS, the Borough of Bellmawr (“Borough” and/or “Bellmawr”) determined that it is in the best interests to retain the services of Special Counsel to assist the Borough in prosecution of real estate tax appeals for the Borough (Affirmative Appeals) regarding certain properties believed to be substantially under-assessed; and

WHEREAS, the Borough filed affirmative tax appeals with regard to a certain property known on the tax map as Block 173.03, Lot 16, with a street address of 330 Benigno Boulevard (“Property”); and

WHEREAS, Trevor S. Williams appeared on behalf of the Property owner;

WHEREAS, Special Tax Appeal Counsel recommended a settlement which will increase the combined assessment from \$2,900,000 to \$4,236,300 for 2020, which will result in an increase of taxes of \$51,367.37 for 2020; and which will increase the combined assessment from \$2,900,000 to \$4,289,700 for 2021, which will result in an increase of taxes of \$54,184.40 for 2021; and which will increase the combined assessment from \$2,900,000 to \$4,289,700 for 2022, which will result in an increase of taxes of \$53,142.13 for 2022; and which will increase the combined assessment from \$2,900,000 to \$4,289,700 for 2023; and

WHEREAS, Special Counsel and Mr. Williams negotiated a staggered payment plan, the appeals will be settled according to the following schedule: The 2020 and 2023 appeals will be settled immediately; and The stipulation of settlement for the year 2021 will be signed immediately and held in escrow by the plaintiff's attorney but will not be submitted to the Tax Court before November 16, 2023; and The stipulation of settlement for the year 2022 will be signed immediately and held in escrow by the plaintiff's attorney but will not be submitted to the Tax Court before May 16, 2024.

WHEREAS, Special Tax Appeal Counsel's contract dictates they receive 21.5% of the total recovery; and

WHEREAS, the Borough tax assessor approves this settlement; and

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Bellmawr, County of Camden, State of New Jersey hereby approves the proposed settlement with regard to Block 173.03, Lot 16, with a street address of 330 Benigno Boulevard whereby the assessment for 2020 will increase to \$4,236,300; and the assessment for 2021 will increase to \$4,289,700; and the assessment for 2022 will increase to \$4,289,700; and the assessment for 2023 will increase to \$4,289,700; and

BE IT HEREBY FURTHER RESOLVED, THAT THE BOROUGH COUNCIL OF THE BOROUGH OF BELLMAWR HEREBY APPROVES the fee for Special Tax Appeal Counsel of \$10,932 for 2020, \$10,932 for 2021, and \$10,932 for 2022.
